ADMINISTRATIVE ACTION IN THE EVENT OF RAGGING

The Institution shall punish a student found guilty of ragging after following the procedure and in the manner prescribed here as follows:

- A) The Anti-Ragging Cell of the institution shall take an appropriate decision, in regard to punishment or otherwise, depending on the facts of each incident of ragging and nature and gravity of the incident of ragging established in the recommendations of the Anti-ragging Cell.
- B) The Anti-Ragging Cell may, depending on the nature and gravity of the quilt established by the Anti-Ragging Cell, punish to those found guilty, one or more of the following punishments, namely:
- 1. Suspension from attending classes and academic privileges.
- 2. Withholding/withdrawing scholarship/fellowship and other benefits.
- 3. Debarring from appearing in any internal as well as external examination or other evaluation process.
- 4. Withholding results.
- 5. Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
- 6. Suspension/expulsion from the hostel.
- 7. Cancellation of admission.
- 8. Rustication from the institution for period ranging from one to four semesters.
- 9. Anti Ragging Cell may call upon parents on ragging issue.
- 10. Expulsion from the institution and consequent debarring from admission to provided that where the persons committing or abetting the act of ragging are not identified, the institution shall resort collective punishment.
- 12. Lodge FIR with the local police station and prosecuted for legal/ criminal action.
- 13. The students are also advised that for any further details, visit UGC Website as well as college Website regarding rules and regulations of Ragging in the campus.
